

IRA - REQUIRED MINIMUM DISTRIBUTION

Donors 70 1/2 or older, who pledge \$25,000 or more in total over five years, may fund 100% of their pledge of \$25,000 or more with the Required Minimum Distribution from your IRA. This is offered on a first come first serve basis as we have limited space to use these donations—please contact Bob Hall at (509) 969-7962 to confirm availability. SECURE ONLINE GIVING

Donors are welcome to schedule their gifts online via a secure direct bank transfer or with a credit card. Please visit the following website to complete your gift: www.wsubeta.org/campaign.

If you prefer to donate online, please consider making a gift via a direct bank transfer from your checking account (see the tab next to “Payment Method” on the website) so the campaign will not incur a ~3% credit card transaction fee. If you do wish to donate using a credit card, we respectfully ask you consider adding an additional 3% to fund the transaction fees.

It is understood that the Gamma Delta Building Association will reasonably act in reliance upon your pledge to borrow monies, incur expenses, enter into contracts, undertake projects or obligations, or solicit additional donations or pledges. RECOGNIZING LOYAL DONORS

- Pledges are welcome to be made over five years.
- Commitments of \$5,000+ will be recognized on a permanent plaque in the newly renovated Chapter House.
- Limited tax deductibility – Commitments of \$25,000 or more (over five years) are eligible for tax deductibility to the donor’s personal extent. The availability of these giving vehicles is on a first-come first-served basis and limited based on the total percentage of the project that can be funded as academic space. The Gamma Delta Building Association is partnering with the Beta Theta Pi Foundation to facilitate these gifts of \$25,000 or more.
